PROCEEDINGS OF 8th ANNUAL GENERAL MEETING

The 8th Annual General Meeting (AGM) of the Members of the GMR Goa International Airport Limited ("Company") was held on Tuesday, September 24, 2024 at 03.00 p.m. (IST) through Video Conferencing ('VC).

• In the absence of the Chairman of the Board, pursuant to the provisions of the Articles of Association of the Company, Mr. Bimal Parekh, Independent Director and Chairman of the Audit Committee, chaired the meeting and called the meeting to order as requisite quorum was present.

- Mr. Rohan Gavas informed the Members that the Statutory Registers and other documents as required under the Companies Act, 2013, were available for inspection throughout the meeting.
- With the consent of the Members present at the meeting, the Notice of convening the 8th AGM, Directors Report along with Annexure(s), the Auditor's Report on the Financial Statements (Standalone and Consolidated) and the Secretarial Audit Report for the financial year ended March 31, 2024 were taken as read. The Auditor's Reports on the Financial Statements (Standalone and Consolidated) and Secretarial Audit Report of the Company for the financial year ended March 31, 2024, do not contain any qualification, reservation and adverse remark.



- Mr. Rohan Gavas informed the Members that, in compliance with the provisions of Companies Act 2013 and Secretarial Standard - 2 issued by the Institute of Company Secretaries of India on General Meetings, Mr. Bimal Parekh- Independent Director and Chairman of the Audit Committee, Mr. P. - 4. To appoint a director in place of Mr. Grandhi Kiran Kumar [DIN 0061669], who retires by rotation and being eligible, offers himself for re-appointment.
- 5. To appoint a director in place of Mr. Indana Prabhakara Rao [DIN 3482239], who retires by rotation and being eligible, offers himself for re-appointment.

Special Business:

- 6. Appointment of Mr. Alexis Riols [DIN: 10497928], as a Director of the Company.
- 7. Appointment of Mr. Rebet Thibaut [DIN: 10563982], as a Director of the Company.
- 8. Ratification of remuneration of Cost Auditors.
- 9. Approval for revision in the borrowing limits of the Company.
- 10. Approval for the creation of lien/encumbrances over the assets of the Company.

All the Resolutions i.e. from 1 to 10 as per the Notice of 8th AGM were passed unanimously by the Members attending the meeting by way of show of hands in the meeting. The AGM of the Company was concluded at 03.40 p.m. (IST).
