- Net Worth (paid up equity share capital plus Other Equity (including gain on equity instruments designated at Fair Value through Other Comprehensive Income) as on March 31, 2025 is ₹49,794.62 Lakhs (March 31, 2024 : ₹76,719.90 Lakhs).

- a) Current Ratio represents current assets / current liabilities.
